SOUTHEAST CHRISTIAN CHURCH (ALL CAMPUSES) MIDDLE SCHOOL STUDENT - MINOR LEGAL RELEASE AND PERMISSION AGREEMENT

I hereby give permission for my child, named below, to participate in one or more of Southeast Christian Church Student Ministry activities and outings including, but not limited to, small home groups, field trips, concerts, off-site service projects, Christ in Youth multi-day events, out of town trips, overnight stay or trip, lock-ins, summer camp at Country Lake, including pool and lake swimming if approved by Country Lake lifeguards (not pond or river swimming nor any other lake swimming), paintball, zip-lining and high ropes course at Country Lake Camp, hiking, camping, retreats, and transportation by bus, van, car or other form of transportation (each referred to herein as an "Activity").

In consideration of the acceptance of my child's participation in each Activity sponsored by Southeast Christian Church of Jefferson County, Kentucky, Inc. (the "Church") and as an inducement to planning each Activity and permitting my child to participate, the undersigned (hereinafter, "I") agrees as follows:

I, on my behalf and on behalf of my child, hereby fully and forever release and waive and agree not to bring or cause to be brought any and all claims, demands, actions, or causes of action of every possible kind and nature whatsoever I or my child might assert, including, without limitation, claims for personal injury, wrongful death, or property damage, whether or not absolute, known or unknown, or otherwise against the Church or any of its subsidiaries, elders, officers, employees, representatives, agents and volunteers (collectively referred to herein as the "Releasees") by reason of, arising out of or relating to my child's participation in each Activity. I, on my behalf and on behalf of my child, release the Releasees and waive all such claims against the Releasees for any injuries or damages caused in any manner whatsoever whether or not any such liability is attributable to the absence of ordinary or even slight care by the Releasees arising out of each Activity.

I give my permission to the Church or its designees to secure medical treatment for my child. I also give my permission to the medical personnel selected by the Church or its designees to secure treatment and provide for the complete medical care of my child.

I give the Church, and any person acting under its authority permission to publish, distribute, broadcast, televise, promote, license, sell and copyright for all purposes, any photograph, videotape, motion picture or sound recording produced directly by the Church or under its sponsorship, which may include the image or likeness of my child and/or the voice of my child. I also authorize the Church to reproduce, amplify, simulate, filter or otherwise distort the voice of my child and all instrumental musical and other sound effects produced by my child. In addition, I authorize the use of any printed material in connection therewith. I release, on my behalf and on behalf of my child, all claims against the Church with respect to copyright ownership, publication and right to privacy. I agree that neither I nor my child shall receive any fee and that all rights, title, and interest to the above materials and use of them belong to the Church. I understand and agree that these materials may be duplicated or distributed with or without charge, and/or altered in any form or manner without future/further compensation or liability, in perpetuity.

I further agree that I have read and understand this Agreement; I am the parent or legal guardian of my child named below; the execution of this Agreement is continuing in nature; it is my knowing and voluntary act on my behalf and on behalf of my child; this Agreement is binding upon me and my child's heirs, executors, administrators and legal representatives; I am under no duress or undue influence to execute this Agreement; I represent that the information provided in my child's application to participate in each Activity is true, complete and correct in all respects; it is my intention with this Agreement, on my behalf and on behalf of my child, to make a complete, general, and unconditional release of any and all claims whatsoever against the Releasees, as set forth above.

This Agreement shall be effective from the date signed below until the date of the earlier of the 31st day of August of my child's completion of middle school **or** the receipt of a written declaration signed by the parent or guardian, that this Agreement shall no longer be effective with regard to any act or event from and after the date of the receipt via U.S. Mail of the written declaration addressed to Southeast Christian Church of Jefferson County, Kentucky, Inc., 920 Blankenbaker Parkway, Louisville, KY 40243-1845, attention: General Counsel.
